

PRIVACY POLICY update European regulation 679/16

COLLECTED DATA

Case4Freedom srl collects the indispensable data for a correct management of the commercial relation inherent to its own activity and those required by the regulations in force for a correct fiscal management.

DATA USAGE

- Case4Freedom uses the data it collects for the following purposes:
- Providing a Service;
- Send promotional communications with your specific consent if required;
- Evaluate and analyze the market of Case4Freedom and its customers, products, marketing campaigns and services to better
 understand, through statistical processing where necessary, customers in order to offer them communications, services and the
 most relevant experience for them.
- Ask Case4Freedom users to express their opinion about services and conduct customer surveys with their specific consent if required;
- Provide after-sales service
- In other way with the specific consent of the interested parties.

DATA SHARING

- Business Partners. Case4Freedom can share information from stakeholders with reliable business partners, including, without
 limitation, its own tax, administrative and legal advisors. These entities may use this information to provide our users with the
 services requested by them, and may send them information and product specifications and other material with their specific
 consent.
- Service provider. Case4Freedom may disclose the data of interested parties to carefully selected companies that provide
 services for us or on our behalf, such as companies that collaborate with Case4Freedom also for customer satisfaction, billing,
 or sending e-mails on behalf of Case4Freedom. These entities are limited, on the basis of contractual provisions, in the
 possibility of using such data for purposes other than the provision of services on behalf of Case4Freedom.
- Other parts required by law or necessary to protect the Case4Freedom services. Situations may arise in which Case4Freedom
 communicates the information of the interested parties to third parties: to comply with the law or to respond to mandatory
 legal action, for example a search warrant or other court order;
- Other parties in connection with company operations. Case4Freedom can communicate the data of the interested parties to third parties in the context of a merger or a transfer, an acquisition or a sale, or in case of bankruptcy.
- Other parties, with the consent or at the request of the interested parties. In addition to the disclosure cases described in this
 Privacy Statement, Case4Freedom may share information with third parties on interested parties when the latter gives their
 specific consent or requests it.

DATA PROTECTION

Case4Freedom takes the data protection of the parties concerned seriously and has taken appropriate technical and physical
measures to protect the information collected in connection with the services provided. However, note that although
Case4Freedom takes reasonable precautions to protect information, no website, Internet transmission, computer or wireless
connection is completely secure.



INTERNATIONAL DATA TRANSFER

DATA CONSERVATION

Case4Freedom will not store the personal data of the interested parties for longer than necessary for the purposes for which they were collected. This means that data will be destroyed or deleted from Case4Freedom systems when they are no longer needed.

Case4Freedom shall take appropriate measures to ensure that the data of the parties concerned are processed and stored according to the following principles:

- 3. Only for the time necessary to fulfill the purpose for which they are collected, processed, or for a longer time, if it is required under a contract, by applicable law or for statistical purposes, provided they are subject to adequate protection
